Junior (P-3) Acceptable Usage Agreement

1. BACKGROUND:

We have the privilege at Concongella Primary School to be able to offer 1:1 iPads across the whole school and some laptops available for use. With this comes the responsibility of all users to behave in an appropriate manner at all times. In our digital world we must all remain safe, this means not sharing passwords or personal information. Students are living in a very different world to the one their parents are so it is important that we have a shared understanding of our behaviours and responsibilities when using the schools ICT equipment.

3. OTHER DEVICES

Many students now have access to iPads, iPods, phones, Smart Phones and other handheld gaming equipment at home. However, it is not appropriate that these be brought to school or used at school. If you bring a phone or gaming equipment at the request of your parents,

it must be placed in the box in Kristie's office upon arrival and taken out at the end of the day. No home devices are to be used at school.

4. CONSEQUENCES:

Failure to Comply: 2 warnings, then pick up 10 pieces of rubbish in the yard at recess/ lunch time.

Damage to an iPad will be judged on a per case basis, ie, if damage occurs through minimal or unforeseen fault of the user lesser consequences, if the user was behaving in a manner that could have been avoided, more severe consequences.

Code Red Offences: Instant loss of full access for 1 full day; you must make up any lost work at recess/ lunch time.
